BUSTED A NOTORIOUS HB BY NIGHT CRIMINAL GANG- 5 HELD.

The sleuths of CCS Shamshad team on 13.08.2020 apprehended the hard-core House breaking night gang (**5 members**) and recovered **Gold ornaments weight about 175 Grams, Silver ornaments weight about 350 Grams, One Honda Activa, five cell phones and house breaking equipments.**

DETAILS OF THE ARRESTED ACCUSED:

- A-1** Kosuri Srinivasa Rao, S/o Late. K. Manga Raju, aged. 54 yrs, Occ. Previously worked as a Teacher presently un-employed R/o. Kirshnanagar, Chilakaluripeta, Guntur dist, Andhra Pradesh State, R/o.
- A-2** Rathlavath Shanker Naik @ Shanker @ Rajesh Reddy @ Rajesh s/o Krishnaiah age 28 yrs, occ: un employee, R/o Panchavati Residency, near Railway station, Secunderabad N/o Nagarla Banda Thanda, Thumukunta, Veepanagandla (M) Wanaparathi Dist.
- A-3** Mallachervu Rama Rao S/o. Late. M. Narayana Rao, aged about 51 yrs, Occ. Auto Driver R/o. Kirshnanagar, Chilakaluripeta, Guntur Dist, Andhra Pradesh State, N/o Nizampet, KPHB, Hyderabad.
- A-4** Chinthala Sisindhri @ Surya s/o Subbaiah age 24 yrs, occ: labour Caste: Yadav r/o Kirshnanagar, Chilakaluripeta, Guntur dist, Chinthalapalem (v) CS Puram (M) Prakasham dist.
- A-5** Muvva Suresh Babu s/o Nagabhushanam age 43 yrs, occ: HP petrol pump Supervisor at Pathipadu r/o 10th line, Near Koleramma temple AT Agraharam Guntur N/o Ravinutala (V) Korisapadu, (M) Prakasham dist.

PREVIOUS HISTORY OF GANG :

A1. Kosuri Srinivasa Rao (Gang Leader):

He is native of Giriboianavari Street, Innispeta, near V.T. College, Rajahmundry, Andhra Pradesh State.

While he was working as a teacher at Kalwakurthy he met one Mala Yogendhar Kumar HB Offender through his brother Uday kumar, who is working as a attender at the same said school. In the meanwhile, once Uday kumar requested Kosuri Srinivasa Rao to mortgage 10 Tolas Gold in the pretext of his sister marriage in the year 2009 at Kalwakurthy. Later Mala Yogendhar kumar, brother of Uday kumar was arrested by Bowenpally police basing on his confession he was arrested. Again Kosuri Srinivasa Rao made arrangements in releasing the gold from gold shop to Uday kumar. From then

onwards he was habituated in selling the stolen gold and also releasing it and getting double benefit., two way profit. So far he made arrangements and got habitual notorious HB offenders by spending lavishly on each offender (Advocate fees, arranges surities etc.)

In this way he planned and released

- 1) Mala Yogendhar Kumar
- 2) Ithadi Koteswar rao
- 3) Jallapally Narsing rao
- 4) Shankar Naik
- 5) Mallecheruvu Ramarao
- 6) Jallapally Chanti
- 7) CH. Sisindri

After releasing them he provide accommodation in separate rooms/hotels and arranges HB implements/tools ., Screw driver, Iron rods, cutting plier, Torch lights, stolen two wheelers etc. He spent money among for his lavish life style and to release other offenders. He started committing property offences (House Breakings) from the year 2009 and involved in **(48)** property offences in Telangana and Andhra Pradesh states. On 16.07.2020 he was released on bail from Ongole District prison.

A2. Rathlavath Shanker Naik :

He is native of Nagarla Banda Thanda, Veepangandla (M) Wanaparathi Dist. He started committing property offences (House Breakings) from the year 2012 and involved in **(51)** property offences in Cyberabad, Rachakonda, Hyderabad, Mahaboob Nagar of Telangana and Vijayawada, Guntur, Ongole, Nellure of Andhra Pradesh states. On 16.07.2020 he was released on bail from Ongole District prison.

A3. Mallachervu Rama Rao :

He is native of Kirshnanagar, Chilakaluripeta, Guntur Dist, Andhra Pradesh State, Started committing property offences (House Breakings) from the year 2011 and involved in **(47)** property offences in Cyberabad, Rachakonda, Hyderabad, Mahaboob Nagar, Kareemnagar, Kammam, Nalgonda, Warangal of Telangana and Vijayawada, Guntur, Ongole of Andhra Pradesh states. On 07.08.2020 he was released on bail from Guntur Jail.

A4. Chinthala Sisindhri:

He is native of Chinthalapalem (V) CS Puram (M) of Prakasham District, Started committing property offences (HBs & Auto Mobile thefts) from the year

2014 and involved in (20) property offences in Prakasham and Gunture of Andhra Pradesh state. On 28.07.2020 he was released on bail from Ongole Jail.

A5. Muvva Suresh Babu:

He is native Ravinuthal (V) of Prakasham Dist. His eking hoods migrate to Guntur. He was arrested in Cheating cases from Pathipadu PS of Gunture district in the year 2020 March. While he was in Guntur jail he met Srinivasa Rao and well acquainted with him. After releasing from jail he arranged necessary needs of Srinivasa Rao and joined his team and used to dispose stolen property. On 30.03.2020 he was released on bail from Guntur Jail.

FORMATION OF THE CRIMINAL GANG :

The accused A1. Kosuri Srinivasa Rao (Gang Leader) released from jail on 16-07-2020 from Ongole jail and made arrangements releasing of other gang members. Later again he formed a gang with Rathlavath Shanker Naik, Mallachervu Rama Rao and Muvva Suresh Babu and started committing offences in the limits of Cyberabad and Telangana.

MODUS OPERANDI :

Kosuri Srinivasa Rao keeps his associates in his secrete shelter places. They used to commit theft of motor cycles and procure house breaking equipments i.e., rod, Screwdriver and cutting plier, etc. They move in different colonies in the night time and identified locked houses by moving on motor cycles. As per the direction of their gang leader, some of the gang members proceed to identified locked house and break the locks with available equipments and opened the almarah with screw driver and committed theft of Net cash, gold ornaments, Silver ornaments/articles, etc. and remaining persons keep watch at some distance at the time of committing offences and also dispose the stolen property.
