**ONE HABITUAL OFFENDERS GANG WHO WERE COMMITTED THEFT OF TEAK AND OTHER WOODEN DOORS AND DOOR FRAMES FROM NEW CONSTRUCTING HOUSES WAS APPREHENDED BY RAJENDRANAGAR POLICE AT BANDLAGUDA, RAJENDRANAGAR.**

**DETAILS OF ACCUSED AND THEIR HISTORY:**

**A-1)** Mohammed Zaheer S/o Mohammed Saleem, Age: 24 years, Occ: Car Driver, R/o H. No. 10-3-72/B, Near Aziziya Masjid, Mehidipatnam, Humayun Nagar, Hyderabad.

**A-2)** Mohammed Afrose Khan S/o Mohammed Rafiq Khan, Age: 22 years, Occ: Welder, R/o Mehidi Colony, Langerhouse, Hyderabad.

**A-3)** Mohammed Fareeduddin @ Shoheb S/o Zakiuddin, Age: 27 years, Occ: Bakery material supply, R/o Vijaynagar Colony, Mehidipatnam, Hyderabad.

**A-4)** Shaik Waheed Pasha @ Waheed S/o Shaik Abdul Rehman, Age: 23 years, Occ: Welder, R/o H. No. 10-2-300/23, Laxmi Nagar, Vijaynagar Colony, Mehidipatnam, Hyderabad.

**A-5)** Pasupula Saikumar @ Kiran S/o Late Suresh, Age: 19 years, Occ: Welder, R/o H.No. 10-2-300/33, Laxmi Nagar, Vijaynagar Colony, Mehidipatnam, Hyderabad.

**A-6)** Noor- Receiver (**Absconding**).

The accused A-1 to A-5 were hails from Hyderabad city, all are close friends, playing the cards together at Vijay Nagar Colony and they addicted to bad vices, moved together and used to spend the money lavishly, but income of the accused persons is very meager to meet their lavish expenses. On that

in order to continue their lavish life they met and hatched a plan to commit theft of wooden items like doors and door frames to gain monetary benefits under the directions of A-1 Zaheer who formed the gang and they committed the above offences selecting the newly constructed building/houses from the last two years.

### **ARREST**

The accused persons were committed this type of offences from the last two years in the limits of Rajendranagar and other Police Stations in Cyberabad and Hyderabad Commissionerates. On that Rajendranagar Police were made sincere and continues efforts for apprehension of the offenders and finally apprehend the accused on 03-01-2018 in the early hours at Bandlaguda, Rajendranagar, brought them to PS and interrogated them thoroughly and tactfully, on interrogation they confessed the above offences. The police recovered property all worth to the tune of Rs.7,00,000/- of Teak and other wooden doors and door frames also seized vehicles, cell phones from their possessions which were used in the commission of offences.

### **TEAM WORK**

The good work done by the team of Rajendranagar Police Cyberabad succeeded in arresting the accused under the direct supervision of DCP Shamshabad and A.C.P. Rajendranagar, the Detective Inspector V.Nagaiah, and his crime staff were appreciated by C.P. The arrested accused being remanded to judicial custody.
