# CYBERABAD POLICE CRACKED THE SENSATIONAL MURDER CASE OF HOUSEWIFE



The Cyberabad Police have successfully solved the murder case of a housewife, who was murdered in her own flat at Swan Lake Apartments, Kukatpally. The two maid servants who are involved in the assassination and one other who harbored them were apprehended at Ranchi, Jharkhand, and are being produced before the Hon'ble Court for transit warrant.

- 1) Harsh Kumar @ Harsh, Age: 20 years, Occ: House help, N/o.Ranchi, Jharkhand State.
- 2) Roshan Singh, Age 22 yrs, Occ: House help, N/o. Ranchi, Jharkhand State.
- 3) Raju Varma, Age 19 yrs, R/o. Ranchi, Jharkhand.

<u>Details of deceased</u>: Renuka Agarwal w/o Rakesh Kumar Agarwal, age 50 yrs, R/o. Tower I, Swan Lake Apartment, Kukatpally.

## Case Background:

On 10-09-2025, on receiving complaint from deceased husband that his wife was killed in their own flat, further suspecting their house hepl Harsh Kumar and neighboring House help Roshan, a case was registered, and investigation was taken up. As per the evidence, above people were strongly suspected and teams were formed and both the suspects and one who harbored them were caught yesterday late night in Ranchi.

All the accused people are hails from Ranchi of Jharkhand State and A1 & A2 had come down to Hyderabad for livelihood. They secured employment as domestic help. Harsh Kumar works in the complainant's flat, and Roshan works in 14<sup>th</sup> floor flat of Swan Lake Apartments. Having developed a criminal intent and with a motive to make easy money, the accused A1 & A2 carefully observed the movements of the

complainant's family. On 10-09-2025, after the complainant and his son left for business, both accused colluded and attacked Smt. Renuka Agarwal, tied her hands and legs, and brutally slit her throat & assaulted her to death. Thereafter, they looted gold ornaments on the deceased, some cash, rold gold items, watches and decamped away to Ranchi, Jharkhand where they were harbored by Raju Varma.

During investigation, CCTV footage confirmed their involvement. With sustained efforts, Four Police teams consisting of local Police, CCS and SOT caught the accused persons at Ranchi, Jharkhand. On interrogation, they confessed to the crime and at their instance, the following material is being seized.
