

## **PRESS NOTE**

### **ARREST OF INTER STATE DACOIT GANG MEMBERS**



On 12.08.2025, six unidentified armed offenders entered Khajana Jewellers, Chandanagar. They opened fire at Dy. Manager, injuring his left knee, and looted around 10 Kgs of silver articles having gold coloured. In this regard a case was registered at Chanda Nagar Police Station U/s. 310 (2) r/w 311, 118 (2), 115 (2), 127 (2), 324 (3), 351 (3) & 254, 317 (3), 57, 61 BNS and Sec. 25 (1B), 27 (1) of Arms Act vide Crime No. 890/2025.

In this connection (2) accused namely **Aashish Kumar Singh & Deepak Kumar Sah** were arrested on **15.08.2025** at **Jejuri**, Pune and Hyderabad respectively. At the confession of accused recovered (900) grms of looted silver articles.

Further (2) more accused namely **Anish Kumar Singh & Prince Kumar Rajak** were arrested on **19.08.2025** at **Pimpri**, Pune. At their confession of accused recovered (1,015) grms of looted silver articles and one country made firearm.

Apart from the above (2) more prime accused namely **Prince Kumar Bharati (main leads) & Rohit Kumar Rajak @ Rohit Baitha (who fired the weapon)** were also arrested on 22.08.2025 at **Ankleshwar**, Gujarat. The accused have informed that they have hidden a weapon and some of the stolen ornaments which will be recovered after taking Police custody.

The accused involved in this case are having previous criminal history and habitual offenders.

**Rohit Kumar Rajak @ Rohit Baitha** involved in a case vide No. 208/2025 U/Sec 310(2), 311 BNS & 27 Arms Act Ekma PS of Saran Dist., of Bihar State (Absconding).

Investigation is continuing to trace out and apprehended the remaining (03) accused and to recover the remaining property.

The above arrests were made with the combined efforts of SOT, CCS, L&O staff Chadnagar PS of Cyberabad Police Commissionerate.

The management of Jewellery shops are advised to have adequate security mechanism during the operational hours and to have intrusion alarm panel at their establishment and to nearest Police Stations to thwart such incidents.
