

PRESS NOTE

1.RIGOROUS IMPRISONMENT FOR LIFE AND FINE OF Rs. 1000/- for Section: 302 IPC (Murder)

2.RIGOROUS IMPRISONMENT FOR (5) YEARS AND FINE OF Rs. 1000/- for Section: 382 IPC

3.RIGOROUS IMPRISONMENT FOR (1) YEAR AND FINE OF Rs. 1000/- for Section: 498(A) IPC

In Cr.No.389/2022, Vide SC.No.1636/2022, U/s 498(A), 302, 382 IPC of PS KUKATPALLY CYBERABAD.

On 16.05.2022 at 1930 hours received a Complaint from Sundar S/o Sangappa in which he stated that he has one Sister-Surekha. About 20 to 25 years ago she got married with Santosh (Accused) and they blessed with two sons and one daughter. Two years back they came to Hyderabad to eke out their livelihood from Humnabad Taluq, Bidar District. His sister (Victim) was working as Housekeeping along with his wife. His brother-in-law (Santosh) did not work and consumes liquor daily and harassing the victim mentally and physically. On 15-05-2022 at about 2100 hours his brother-in-law (Santosh) went to their house in drunken condition and beaten his sister mercilessly, victim informed the same to the complainant. In the night he had not asked him, by thought that why he involved in their family matter. On 16-05-2022 at about 0745 hours the complainant's wife went to victim's house to go to work and his wife shouted & cried, immediately he went to victim's house and observed that victim received bleeding injuries on her lips, ears, chest, knees and Strangulation injuries around her neck. Immediately he shifted her to Gandhi Hospital. On enquiry he came to know that his brother-in-law had beaten his sister (Victim) mercilessly and attempted to kill her and stolen gold Pustee & Gundlu from her neck and left from there. Hence, he requested to take necessary action.

Basing on that, the then SHO P. Narsing Rao, Inspector of Police registered a case vide Cr. No: 389/2022, U/s 498-A, 307 IPC and took up the investigation. While undergoing treatment the victim Surekha died on 19-05-2022 at Gandhi Hospital, on that section of law was altered from 498 (A), 307 IPC to 498 (A), 302, 382 IPC.

While the investigation, P. Narsing Rao, Inspector of Police arrested the accused Kulbe Santosh S/o Sharanappa Kulbe, age: 46 years, Occ: Labour, R/o Khaithlapur, Moosapet, Kukatpally N/o Madargavun Village, Humnabad Taluq, Bidar District, Karnataka State and remanded him to Judicial Custody. During the Investigation the IO collected all relevant evidences and filed the charge sheet before the Hon'ble Court.

During the Trail the Police and Public Prosecutor G.V. Rama Krishna Rao produced the Prosecution witnesses and relevant material evidences, after completion of the trail Sri. M. Venkateshwara Rao, Honorable Judge, III Addl. District and Sessions Judge-Cum-Principal Family Court, Medchal-Malkajgiri District at Kukatpally has pronounced judgment and given conviction as mentioned above to the accused for committed murder to his wife by "STRANGULATION".
