

## **PRESS NOTE**

### **Notorious organized gang of prostitution ( ITP Act ) busted by AHTU, Cyberabad Police**

This is a case of **Immoral Traffic (Prevention) Act** busted by the Anti Human Trafficking Unit of Cyberabad Police in which 17 persons were arrested for procuring women from different places across India, posting ads in the websites, contacting the customers through call center and WhatsApp, facilitating the customers to reach the victims and indulge in prostitution in different hotels, Oyo rooms and collecting money for this organized prostitution.

- Total number of accused arrested – 17
- Total number of cases the accused were involved - 39
- Total number of victims involved in prostitution – 14,190
- Drugs used in the business – MDMA
- Victims are from – AP, Telangana, Karnataka, Delhi, Mumbai, Kolkata, Assam, Bangladesh, Nepal, Thailand, Uzbekistan, Russia etc.
- Victims mainly Coming from % wise - West Bengal 50 %, Karnataka - 20%, Maharashtra - 15%, Delhi - 07, Other States - 05%, Other countries - 03%.
- Websites used - Locanto, Skokka, Hyderabadscorts, callgirls in Hyderabad,Luxuryescortservices, [www.myheavenmodels.com](http://www.myheavenmodels.com), [www.natasharoy.in](http://www.natasharoy.in)
- Call centers operated from – Delhi, Bangalore, Hyderabad
- Main mode of communication – WhatsApp groups (each group having 300 organizers)

Cyberabad and Hyderabad Commissionerates and in most of the cases they are absconding.

During interrogation and confession of the accused, it was observed that a number of pimps are there from different states, formed different WhatsApp groups subject wise, like organizers, suppliers, ad makers, website and call center people and communicating with each other for the business and a large number of victims were dragged into this profession by luring them with luxurious life style, easy money and in some cases, in the pretext of providing jobs.

In most of the cases, this Prostitution is organized from Websites like: **Locanto, Skokka, Hyderabadescorts, callgirls in Hyderabad, Luxury escort services, [www.myheavenmodels.com](http://www.myheavenmodels.com), [www.natasharoy.in](http://www.natasharoy.in)** etc., and using WhatsApp Status and their platform for regular communication is WhatsApp.

### **MODUS OPERANDI**

At first the Broker (victim supplier) will approach the victim and he puts her photos in Organizers WhatsApp groups, then organizers will select profile (victim's photos) and organizer books hotel and Flight tickets to the victims. Thereafter victims come and stay in hotels. Then, organizer will keep these victims pictures in WhatsApp groups and Call girl websites like Locanto, Skokka, [www.myheavenmodels.com](http://www.myheavenmodels.com), [www.natasharoy.in](http://www.natasharoy.in) etc,

By seeing these adds, customers will call to WhatsApp number or message to WhatsApp, then the call center persons engage the customer in phones by telling the details and guide up to hotel and after that they will inform to organizer about the customer and share his phone number to the organizer. Then he takes conference with the victim and customer and send to hotel room for taking service from the victim.

***They pay money by cash or Phone pay, Google pay or Paytm etc., In this format organizer will pay 30 % to victim, 35% to Ad posting and call center persons, 35% to Organizers, If Organizer only does business in WhatsApp without any ads etc., just have to pay 30% to victim and remaining 70% to Organizers.***

Commission based prostitution is also most popular in this field, mainly one organizer will hire victim and post her pics in Organizer WhatsApp groups, if any of the organizers old customers approach them, they will guide those customers to the Organizer who has hired the victims, and those organizers will pay commission to the Organizer who sent customers.

### **Apprehension of Accused**

Collected information from the victims, their phone numbers and various other sources regarding who are doing this business in city and from which

state victims are sent to Hyderabad and who is the big organizer etc. Basing on the information,formed special teams to apprehend the accused, on 15.11.2022 we arrested **Salman @vivek and Irfan @ Vikas** at Suncity, on thorough interrogation they have given other information about the Organizers in Hyderabad by the above lead started to track the other important accused persons on 18.11.2022 arrested **Adeem @ Arnav @Abhay, Sameer and Harbhinder Kaur @ Simran Kaur @ Anika** at Somajiguda in their room.**Total 5 organizers were arrested**,by interrogation and by their WhatsApp groups and contacts etc, we collected important Organizers list from all over India, suppliers of victims from across India,Ads making and posting agents list, Call Centers and Website owners list, fake SIM providing persons list, fake Aadhar making persons list etc.

In 2019, **Adeem @ Arnav @Abhay** started business and since past 03 months, Sameer joined with Arnav and both are working together. Arnav and one Anika were living together. He supplied around **950 victims** into prostitution from different states of India, mostly from Mumbai, Kolkata and Delhi. **At first Sameer was consuming drug at Tolichowki during that time Arnav has seen him and he also consumed. One drug dealer SofinPatel @ Abbas, was sending drugs to Arnav with the help of Guddu Ali Sam, R/o. Tolichowki, he also sells drugs to him.**

In 2018, **Sameer** Started business with the support of **Farooq @ Samar**, after some days one Arnav joined with Farooq and Sameer. In 2019, Sameer went out from them and started his own business. He used 20 hotels for prostitution and supplied **around 850 victims** into prostitution from different states of India, mostly from Mumbai, Kolkata and Delhi. Sameer's friend Alisam, R/o. Golconda, he introduced drugs to him and he also consumed drugs.

From the Year 2016 **Salman @ Vivek** worked as concierge employee in Katria Hotel at Somajiguda till 2017, later he worked in the Park Hotel as a Reception Calls and one touch and Concierge from 2017 to 2019, when his victims stay in hotel, thereafter he became full fledged organizer in August 2020. Till now he is working with Irfan @ Vikas.

In the Year 2021, Irfan @ Vikas met one person by name Salman at Golconda, mean time he explained call girls business and he offered money and suggested to do that work, he was impressed and joined with Salman and working together till now.

On 26.11.2022, arrested one Jogeswar Rao @ Nani and Saibabu Goud @ lucky @ Mechanic Sai both are famous PITA organizers they were doing call girl business from last 12 years, they supplied **around 2500 victims** into prostitution from different states of India, mostly from Mumbai, Kolkata and Delhi. During investigation, we collected important PITA Organizers phone numbers from their phones.

Thereafter on 29.11.2022 arrested one **Shailendra Prasad @ Saleem** was arrested by the team, he is most senior PITA organizer from the last 15 yrs, he maintained call center for prostitution. He brought around **1800 victims** into prostitution from all over India and collected important chats and contacts from his phone.

On 02.12.2022 arrested one MohdAfsar @ Sahil who is famous PITA Organizer he is doing this business from the last 16 years, he used around **1750 victims** to prostitution business from all over India, mostly from Kolkata, Mumbai, Delhi. He is addicted to Horse riding betting and he depends mostly on old customers for prostitution.

On 02.12.2022 arrested **Gangadhari @ Ganesh @Gani** at Anantapur, he acts like a hub of prostitution, he gives works to many organizers, he only post the ads in Locanto app and also he will post the victim Pics in his WhatsApp Status, old customers will approach him if needed. He is absconding in cases of Kukatpally and Madhapur Police stations.

On 02.12.2022 arrested **Fayaz @ Vinod Kumar** at Ananthapur, he works as a **tele caller** and contacts the customers and fixes the rate and sends the customers to PITA Organizing place (Brothel House/Hotel) on which he receives commission based income from the PITA organizers, he regularly monitors the customers in WhatsApp and guides them. Mostly depends on old clients only, he is also doing part time cloth business. He is absconding in cases of Kukatpally and Miyapur PSs.

On 02.12.2022 arrested **Sai @ Sai Sudheer at Bangalore**, he is ad making and ad posters in Locanto and other Call girl website, he also works as a tele caller and organizes Prostitution business in Bangalore. He depends mostly on old clients, he procured around **850 victims** into prostitution. He is absconding in cases of Kukatpally PS and Miyapur PS.

On 02.12.2022 arrested **Vishnu @ Shailendhra at Bangalore**, he is PITA organizer and also works as a informer in Hyd, he is having links with **fake aadhar creating persons**, in part time he will do hotel business, he supplied

**790 victims** till now for prostitution from mostly Karnataka, Mumbai, Kolkata and Delhi. He is absconding in Madhapur PS.

On 03.12.2022 arrested **Rishi @ Mohd Abdul Salman** at Hyderabad, he is PITA organizer from the last 6 years, he maintains big profiles in prostitution, he maintains foreign victims also, he supplied around **900 victims** into prostitution from Mumbai, Delhi, Kolkata, Chandigarh, Ahmedabad and other countries Russia, Uzbekistan and Thailand. **He is absconding in Madhapur PS case.**

On 01.12.2022 arrested **Sarbeshwar Rout @ Badal** at Hyderabad, he is PITA organizer from the last 2 years, he is receptionist in Siesta Hotel, Kondapur, he arranges victims to the customers who need service, he had connections with the PITA Organizers, he supplied around **200 victims** into prostitution from Mumbai, Delhi, Kolkatta and **He is absconding in Madhapur PS case.**

On 08.11.2022 arrested one **Kodi Srinivas @ Ram Kumar** at Hyderabad he is PITA Organizer from the last 10 years, he takes individual houses and kept victims in it and organize the prostitution, he brought around **600 victims into** prostitution from AP, Telangana and Kolkatta. He is absconding in Kukatpally PS case.

On 04.12.2022 arrested one **Alisam @ Abdul Rafeeq Khan @ Sam** at Hyderabad he is PITA Organizer from the last 02 years, he supplied around **700 victims** for prostitution business from all over India, mostly from Kolkata, Mumbai, Delhi. He will post ads in Locanto and Callgin websites. He is absconding in Madhapur PS.

***They are responsible for 70% of trafficking and prostitution cases in Cyberabad and Hyderabad Commissionerates. Seized 34 Smart phones and 1 keypad phone, 3 Cars, 1 Laptop and 2.5 grams of MDMA from them.***

**Note: PD act will be initiated against the repeated offenders and organizers.**

**Plea to Public:**

Once again Cyberabad police requests the **innocent victims and Girls** not to get lured to trafficking and prostitution not to entertain the ways of prostitution and easy money. Some of the agents lure the poor girls in the name of jobs and send them for prostitution. Don't trust such job promises, and easy money unless verified by known sources. Oyo Hotels and Other hotels are advised to Cross check the address particulars like Aadhar card and other ID proofs and also to verify the antecedents of single staying customers whilecheck- in and give strict instructions to those who are coming from other states. Further, people are advised to verify the antecedents of the tenant before letting out their building, flat or house on rent. Once the premise is given on rent, if any illegal activity is noticed in the rented premises, it will be seized. If anyone has information about any illegal activities they can approach local police or inform Dial 100 or send message on Whats App No. 9490617444.
